FMB job is to become a part of the fiscal management act included in the Indian Act. Will help set up policies with Council, staff and community. Integrity, relevance and responsibility- 3 pillars. Funded under the fiscal management act. They don't report to ISC or the Government. 2006 Fiscal Management Act came into play. Area of FMB that helps with local funds...tax anyone that touches on your land, such as roads passing through.
